## The NABCOP Summer update

### NABCOP 2020 Annual Report and Public & Patient report now online!

The [2020 Annual Report](#) describes the process and outcomes of care for over 185,000 women diagnosed with breast cancer, between 2014 and 2018. Our [Patient & Public report](#) has been created in collaboration with our patient representatives and advocates, and summarises all key messages within the main report.

### 2020 Annual Report Supplementary materials

We have developed an updated set of supplementary materials for use alongside the 2020 report. [These are available to download from our website](#). Highlights include our popular organisational data viewer where you can view the NABCOP results at an organisation level, a template for local presentation of the NABCOP results, and a local action plan to set out aims for quality improvement based on annual report recommendations.

### Identifying frailty and assessing fitness - key work from the NABCOP

The NABCOP is leading the way in identifying frailty among patients with breast cancer treated in real-world secondary care; recent work by the NABCOP published in *BMJ Open*, details methodology for identifying frailty in patient-level routinely collected hospital data. The components of the [NABCOP fitness assessment form](#) are being collected within COSD v9, which will help us understand the influence of patient fitness in treatment decisions for older women.
