The NABCOP Spring update

COVID-19 pandemic: We are continuing with the processes involved with publishing the 2020 NABCOP Annual Report in June this year. However, due to the rapidly evolving situation across the UK and the rest of the world with the COVID-19 (Coronavirus) pandemic, publication timelines and the launch of the Annual Report may be subject to change. We will endeavour to keep all stakeholders as up to date as possible.

National data opt-out: This service allows patients to opt-out of their information being used for purposes other than their immediate clinical care (such as for audit and research purposes). All NHS organisations are required to be compliant with the national data opt-out policy. Guidance on this is provided on the NHS website: https://digital.nhs.uk/services/national-data-opt-out. For national clinical audits such as the NABCOP, using existing sources of patient data collected by the National Cancer Registration and Analysis Service (NCRAS) in England, individual's opt-out preferences are applied by NCRAS prior to the NABCOP receiving the datasets. We will be publishing further information on how NHS organisations can ensure they are compliant with the national data opt-out, specifically with regard to the NABCOP, in advance of the **30 September 2020 deadline extension**.

COSD Version 9.0: From 1st April 2020 look out for the new NABCOP data items within the breast specific dataset of COSD Version 9.0.
